Backstretch

- The Race Officials reached a settlement agreement with Tom Dunlap as per the AGCO Equine Drug Program Process and Policy Directive No.1 - 2018 regarding two Certificates of Positive Analysis on horses that raced on May 27/18. Mr. Dunlap is hereby suspended five calendar days, June 27/18 to July 1/18, inclusive, and issued a \$1,000 monetary penalty. The horses Kazoomin (Race 1, Fin 2nd) and Tres Fortune (Race 2, Fin 1st) tested positive for the Class 4 drug Dexamethasone and are declared unplaced for all purposes with the exception of pari-mutuel purposes. AGCO Rules 11.31, 15.03.01(a), 15.04.01, 15.04.02.1, 15.04.02.2, 15.04.03, 15.06.01(a), 15.06.03(c), 16.13(c)(d), 24.04, and Policy Directives No.2-2008 and No.1-2018 apply. QH 10798/18.

- Anthony Cunningham was in to be licensed as a Trainer.

- Jockey Cesar Esqueda was explained the Ontario urging rules.

- Jockey Josh Scott excused from five rides today.

Races

- Timer and radio check, OK.

Race 1 – JCOF – #2 Thisdudesonfire (Chelsey Willick) on #3 Caraways Jet Moon (Norman Lloyd DeSouza) and a JCOF/TCOF #5 Hanover Hill Prince (Brian Bell) on #6 Dreams Arising (Neil Husbands) at the start. The video shows that #6 comes down and pressures #5, which results in a chain reaction of all horses to the inside suffering interference. The panel found #6 at fault and the JCOF/TCOF of #5 on #6 was upheld. #6 finished 2nd and was placed 7th for causing interference to #s 1,2,3,4, and 5. NOR for DeSouza.

Race 2 – All Clear

- #3 Brown Arnold (Tony Phillips) broke in the air.

Race 3 – JCOF – #7 Why Not Me Too (Cassandra Jeschke) on #8 Up Your Bet (Tony Phillips) and Stewards Inquiry between #3 Gatlinberg (Cory Spataro) and #4 Code Name Valor (Ed Walton). The video shows that #7 goes out first towards #8 and Jeschke checks her horse. #3 and #4 are moving out together and are clear of #7. The panel did not find sufficient video evidence to warrant a placing.

- #8 Moons On My Pjs (Neil Husbands) was a vet scratch at the gate. Refund \$182.

- #3 Jrs Painted Dancer (Tony Phillips) and #5 Barn Royalty (Norman Lloyd DeSouza) broke slow.

Race 7 – All Clear

- Spoke with Ramiro Sanchez Castillo (#5 Ittakestwotootango) about riding his horse through the wire.

- #3 Peves Braveheart (Max Badal) broke in the air.

Race 10 – Inq/JCOF – #4 Lummis First (Cassandra Jeschke) on #6 Pappa Trick (Ed Walton) and #7 Eyesa Wild Boy (Ramiro Sanchez Castillo) at the break. Inquiry also looked at #3 Jimmy Boyz Cartel (Brian Bell) at the start. Video shows that both #3 and #6 break into #4 and #7 is clear of the inside horses. #3 finished 5th and was placed 6th for causing interference to #4 at the start.
