Office:

- The Stewards held a virtual review with Pony Person Laura Estey concerning her failure to report to the Clerk of the Scales on September 28, 2020. Ms. Estey was found to be in violation of rule 15.09.01 (*not complying with generally accepted standards*) and was assessed a \$100.00 monetary penalty. Ruling #1083533.
- The Stewards held a review with Groom Jeanette Drew concerning an incident in the test barn on September 28, 2020. Ms. Drew was found to be in violation of AGCO rules 16.05 (b) & (c) (*show disrespect towards a Race Official by words or actions*). Ms. Drew is subject to a \$200.00 monetary penalty. Ruling #1083813.
- Time checks complete.

Race 1:

- #2 Hanover Hill Sam (Ten Harriott), (finished fifth) was away slow.

Race 2:

- #4 Jess as Sweet as Me (Ed Walton), (finished third) broke slowly.

- Sparka Winning Shake (Jose Nabor Cruz), (finished sixth) broke slowly and in the air.

Race 6:

- Hand timing was utilized for this race due to a malfunction of the electronic timer. 13.070 seconds.

Race 7:

- Stewards inquiry. Reviewed the break by #4 Kits Award (Norman Lloyd DeSouza), (finished seventh).
#4 does rear up on the break and pulls on his flipping halter causing his gate to open slightly slower than the rest. The Assistant Starter does release the horse on time. The Stewards determined that #4 Kits Award does receive a fair start.

Race 8:

- Time checks complete.
- Inquiry, Jockeys claim of foul #6 Me Zoomn By (Cory Spataro), (finished sixth) on #7 Ah Candyland (Ismael Eulid Mosqueira), (finished third).
At about one hundred yards out from the gate #6 ends up between horses #7 and #5 Rowdyvision (Ramiro Sanchez Castillo), (finished seventh). #6 does get squeezed slightly between the #7 and the #5 but this occurs because of the #5 coming out to him. No placings are required.
