Bell 1<sup>st</sup>, through stretch, #6 felt that #5 had come out to her a couple of times. Upon review of the pan and front tower camera angles, #6 is outside and there is always room for her. Claim of foul disallowed.

Upon review of front tower and upper pan camera angles, #3 appears to be clear as he moves outward deep stretch. Claim of foul disallowed.
