Stewards' Inquiry regarding the start of #3 Miss Chloe Suspect, horse did receive a fair start, did refuse, no refund ordered. Show wagering was omitted due to only 2 horses competing the race.

Race 2, Stewards' Inquiry, start of #4 I'm a Quick Corona, upon review of the front and upper pan camera angles, #4 does not interfere with the stall doors of the gate opening as it was equipped with a flipping halter, the upper pan shot shows no movement of the horse to suggest it caused the doors to open slower than the rest. Jockey Tony Phillips was unseated from the #4 horse was assessed by EMS and cleared to ride the remainder of the card. A refund of #4 was ordered \$8,340.

Jockey Diego Benitez cited for possible excessive urging. Will review next week.

Race 5, #6, Silver Lyning, on advisement of the Official Veterinarian was scratched at the gate as it was unruly and reared. Refund of \$7,156.

Race 6, Norman Picov Maturity, Jockey claim of foul and Stewards' Inquiry, stretch run, #6, Bodhi, H. Vanek, 7th and #5, Eye Live for Candy, J. Botello 3rd. upon review of the front tower and upper pan camera angles, #5 is pushed out by #4, #5 straightens and #7 comes in slightly over to #6 and pushes that one over to #5. #7 finished 6th and was subsequently placed 7th.
