Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Office: A meeting was held underneath the grandstand with participants today regarding the rule amendments regarding the testing of workouts, starting gate protocols and stabling. In attendance was AGCO Senior Manager of Racing Tanya Cadeau, AGCO Senior Manager of Vet Services Adam Chambers, AGCO Manager of Vet Services Pam Chesterfield and Stewards Brethour, Dorion and Ksionzyk.

Jockey Ed Walton was excused from four mounts. (Races 2,3,5,7)

Jockey Alexis Sanchez was granted permission to use a crop after five satisfactory rides.

There were three Steward scratches (Chicksdigmymoneybags, Jess Carolinas Award, Jess a Deal) because they were entered into speed index races and became ineligible as races over 440 yards distance are not eligible to be used as an acceptable speed index. This exclusion was found in the 2023 Ajax Track Rulebook.

Race 1: Clear.

#3 General Skywalker broke in the air, finished 2nd.

Race 2: Clear.

Race 3: #3 First Golden Rose broke slow.

Race 4: #5 Queen Charlotte (T.Phillips) finished 5th, was having steering issues and fractious throughout the race.

Race 5: Jockey's Claim of Foul: #3 Hanover Hill Justine (T.Phillips) finished 6th, on #2 Joe Checkers (B.Bell) finished 1st, at the break. #3 Hanover Hill Justine broke poorly and compromised her own start. Objection disallowed.

Race 6: Steward's Inquiry and Jockey's Claim of Foul: #3 Down in Carolina (I.Mosqueira) on #2 Caraways Jet Moon (T. Phillips) at the break. #2 Caraways Jet Moon broke outwardly and caused interference to #3 Down in Carolina. As a result, #2 Down in Carolina finished 3rd and was placed 4th, #3 Down in Carolina was 4th placed 3rd. No penalty to jockey Phillips as he did attempt to keep his mount straight.
