Report on day's Events: (Backstretch – accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

- Jockey Brian Bell was found to be in violation of AGCO rule 11.07 (*interference violation*). The violation occurred in race seven on August 16, 2023, while riding the horse Jtc Lil Moonbar. Mr. Bell is subject to a one-day riding suspension that shall be served on September 20, 2023. Ruling #2319428
- Jockey Ed Walton was excused from his mounts today.
- Test strips were utilized in race two.

- Stewards' inquiry and Jockey claim of foul, #1 One Fabulous Wave (Ismael Mosqueira), (finished second and was placed first) on #3 Dark N Stormy (Alexis Sanchez), (finished first and was placed second). Approximately one hundred yards from the start #3 moves towards the rail and comes over across the path of the #1 causing the #1 to check. The #1 is coming out slightly but is straightening out as the #3 crosses his path, costing the #1 momentum. #3 finished first and was placed second for causing interference to #1 after the start.
