### Backstretch:

- The Association Veterinarians on duty today are Dr. Brett Anderson D.V.M. & Dr. Bernd Stanglmeier D.V.M.
- Due to the humid conditions today extra measures are in place for the Equine Athletes and participants.
- Jockey Rachel Isaacs was in for a film review from July 16, 2025, in race one. Ms. Isaacs was assessed a one-day riding suspension that shall be served on August 31, 2025. AGCO ruling number #3307938
- The Stewards did a crop inspection in the Jockeys quarters today.

- #4 Done in Chrome (Rachael Isaacs), (finished fifth) stumbled on the break.

- Jockey Cristian Benitez (#3 Hours to Fly), (finished third) was found to be in violation of AGCO rule 9.27.05 (b) (excessive urging, more than three strikes in succession). Mr. Benitez was assessed a \$200 monetary penalty. AGCO ruling #3308185

- #5 Caraways Sugar Joe (Cristian Benitez), (finished fifth) stumbled on the break.

- #8 Had to Be Ivy was fractious in the gate and was subsequently scratched by the Association Veterinarian.
- Jockeys claim of foul #4 Junoimzoomin (Norm DeSouza), (finished sixth), #5 Special Spice (Cassandra Jeschke), (finished eighth) and #6 A Fancy Arrangement (Rachael Isaacs), (finished seventh) on #9 Relentless Betty (Tony Phillips), (finished second). #9 comes across the track towards the inside. The Stewards determined that #9 does not interfere with #4, #5 or #6. All three Jockey claims of foul were disallowed.
