Review of incident from Race 6 on October 8th in which Jockey Alexis Sanchez' mount was disqualified from 2nd and placed 4th. Mr. Sanchez is assessed a 1 day riding suspension for interference, to be served on opening day of the 2026 Ajax Downs meet. Ruling to follow.

R1: Clear

R2: JCOF: Jockey of #8 "Fate Zoomin" (Cristian Benitez – 8th) on #9 "Ivory Queen" (JB Botello – 2nd) Spoke to both riders and reviewed all video angles.
#8 is away a bit slow, the inside horses come out and push him outwards, but he

does not take up. #9 is clear of #8 by that point and does not impede any other horse.
Disallowed, no change.

R3: Reviewed start. #4 "Twice the Rush" veers outwards and bumps #5.
#4 finishes last so no placings needed.

Spoke with "Ismael Mosqueira" rider of #1 "Quicksipofcorona" about his horse's finish of the race. Mr. Mosqueira advised that his horse was shying from the tote board and thus slowed towards the wire.

R4: Clear

R5: INQUIRY: Reviewed start of #5 "Senator Rose" (Ismael Mosquiera - DNF). Gates appear to open before the Jockey is properly set, and he is dismounted in the gate as the horse departs. This is confirmed by the starter and via video review.

R6: INQUIRY: Reviewed start of #5 "Rushn Valentine" 4th, who hopped at start and was away slowly. Video shows that horse was rearing as gate opened, gate opened on time and assistant starter did not impede the horse's start. Deemed to have received a fair start. No Change.

R7: #8 "Haaave You Met Karma" gets loose in paddock and enters track.
Scratched by Official Veterinarian.

R8: #1 "Sugar Boy Perry" hesitated, broke in air, trailed throughout. Did receive a fair start.

R9: #6 "Phil Jefferson" loses a hind shoe in the paddock. Farrier unable to safely replace the shoe, nor remove the other hind shoe. Races with one hind shoe, announced to public.
Dead Heat for second between #1 "Ice Witch" and #6 "Phil Jefferson"
