### Races:

**Race 1: Jockey's Claim of Foul:** #2 Tell Him No Secrets (J.B.Botello) against #5 Sea to Air (H.Vanek) at the head of the stretch. The stewards determined that #5 Sea to Air had sufficient room to come out ahead of #2 Tell Him No Secrets. Claim of foul disallowed. No placings needed.

The claim was disallowed as they did come together but #4 was already going by and the stewards determined that it was contact from race riding. No placings.
