The Stewards' determined that after speaking with the jockeys' and reviewing the video, that #3 did drift out onto #4. Rider of #3 C.Jeschke stated that #2 crowded her horse after the break. It was determined that the #2 had broke ahead of #3 and there was incidental contact. However, #3 The Batmann kept drifting outward into #4 Snow Moose and hence the placing.
