**Report on day's Events:** (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

### Backstretch:

Jockey Diego I. Benitez was excused from his 5 mounts today.

**RULING# 3736657:** Assistant Trainer Jessica Pascoe found to be in violation of AGCO Rule 16.05 (c) – show disrespect to a racing official. Ms. Pascoe was assessed a \$200.00 monetary penalty.

### Races:

**Race 1:** Clear.

**Race 2:** Dead Heat for 2<sup>nd</sup> place between #3 “Sixes Royal Maiden” (J. Medina) and #6 “Keep Them in Corona” (C. Jeschke).  
#6 stumbled leaving the gate.  
#1 “Corona for Aunt Dd” (B. Bell – 6<sup>th</sup>) was away slowly, trailed.

**Race 3:** #2 “Thirty Ought Six” (C. Benitez – 3<sup>rd</sup>) is fractious in gate, hops at start, recovers to finish 3<sup>rd</sup>. Rest clear.

**Race 4:** #3 “The Fire Witch” (A. Sanchez – 3<sup>rd</sup>) breaks through gate pre-race and dislodges his rider. He is quickly caught by the jockey and assistant starter. He is then re-loaded, breaks slowly, but recovers to finish 3<sup>rd</sup>.

**Race 5:** Clear.

**Race 6: Jockey Claim of Foul:** Rider of #3 “Had to Be Fabulous” (I. Mosqueira – 4<sup>th</sup>) claims foul on #4 “Game Favorite (B. Bell – 3<sup>rd</sup>) for alleged interference leaving the gate. Spoke to both riders and reviewed the available video angles. The incident was clearly caused by #1 “Jjohnpopper” (M. Badal – 5<sup>th</sup>) veering outwards and forcing the #3 in behind the #4, who kept a straight course. JCOF disallowed. No change

**Race 7:** #4 “Cash and Dash” (I. Mosqueira) scratched prior to the start on advice of the Official Veterinarian. Refund: \$1521  
#2 “One Fabulous Wave” (T. Phillips -6<sup>th</sup>) bobbles at start, trails.
